- Iwi providing a mandate for the Pou Tikanga to facilitate the development of the Rangatiratanga/Mana Motuhake Sphere at the national level
  - Collaborating with other national Māori organisations in planning what our Rangatiratanga/Mana Motuhake Sphere looks like in order to prevent “divide and rule” tactics used by government
  - Proactively highlighting acts of Rangatiratanga and Mana Motuhake by whānau, hapū and iwi

## **MATIKE MAI AOTEAROA RESOLUTIONS:**

- Strongly advocating the Rangatiratanga and Mana Motuhake role of the Forum with government and partnering te kāwanatanga o te Karauna in the development of legislation, policies and practices that affect whānau as outlined by Te Tiriti framework and the Relationship Statement
- Ensuring intergenerational continuity through each Iwi that participates in the Forum and the Crown


6.3 That the Forum notes that the Office of Māori-Crown Relations is seeking the assistance of Pou Tikanga to improve their advice to government on the Crown-Maori relationship.



## **MATIKE MAI AOTEAROA RESOLUTIONS:**

6.4 That once the government confirms that it has repudiated the Doctrine of Discovery, the Forum establishes a team to work with them on eliminating racism.

6.5 Given that IACT is a Christchurch based organisation and was born out of the tragedy suffered by people in Christchurch, it is my view that this issue requires the view of Ngai Tahu.

5. Agree that the government investment for housing over the next 4 years guarantees a minimum of 25% of total housing fund and the COVID recovery fund for Iwi/Maori.
6. Agree that this initiative be led through Nga Iwi o Taranaki, Ngati Kahungunu and Te Aitanga a Mahaki with direction for this initiative coming from each quarterly Symposium.
7. Agree that the leadership of this initiative consider the various housing models including planning & regulatory issues, infrastructure, wrap around services and financing options.
8. Agree that an Iwi Housing Symposium be held on the 9<sup>th</sup> and 10<sup>th</sup> of December 2020 in Napier.
