- Concentrate on the total area and confirm the hapū identified in that area
- Concentrate on consolidation and what that looks like for us
- Request for assurance on continuation of meeting administration
- Some applications have had to progress in the meantime
- Clarification that it is the Government that has brought us together for this, not us turning on each other
- Request for clarification on who is leading this kaupapa. Confirm hapū, claimant or lawyers. Currently there is a conflict in dialect from different views
- The end purpose/goal needs to be determined
- Taking responsibility as Maori of living and inhabiting those areas
- Confirmation that there are 62 claimants in Crown space. Jess is gathering information on who is representing which applications/claims
- Hapū is the overarching umbrella of the claim
- Changes in environment and importance of the manu and kai

<b>4.</b>	<b>Current Claims Update</b>
	<ul style="list-style-type: none"> <li>- Everyone should have a copy of the spreadsheet showing claims in Crown Engagement space. If you have not received, email Shanice at <a href="mailto:governance@whaingaroa.iwi.nz">governance@whaingaroa.iwi.nz</a></li> <li>- Currently 62 claimants</li> <li>- If we can't make this work, then those claimants who are only in this Crown Engagement space will have their process end here</li> <li>- Fighting against a legislation which we have to prove that we have had sole occupancy since 1840 to today. This means hapū that are non-existent which is going to make it difficult.</li> <li>- We will need to go back to our claims and get everyone on board as a collective to all help each other forward</li> <li>- Currently there are individual, whānau, hapū, organisation, trust and rūnanga claims</li> <li>- The spreadsheet is colour coded to highlight claims that are currently not known to then possibly be "struck out"</li> <li>- Concept of "struck out" which is the terminology of the judge. Acknowledged as being harsh as there are whānau everywhere that whakapapa back to Whangaroa</li> </ul>
