Filming will be intermittent, according to project schedules, weather and accessibility and appropriateness of filming different marine mammals (minimising disturbance) at different times of year.

This application is for the maximum allowable term, with filming to take place within that period as demand requires.

Maximum cumulative time with marine mammals during a day:

Maximum encounter time with marine mammals - 1-2 hours at a time.

Cumulative encounter time spent with marine mammals – if very lucky maybe up to 5 hours per day. Attention will always be given to ensure disturbance to the marine mammals is minimised wherever possible - this will determine encounter time. When evidence of disturbance is observed, encounter will be terminated.

Interaction with any marine mammal species will only be initiated according to best practice that minimises disturbance. These best practices, including when, how, how long, and when to terminate encounter, will be determined through Kina's extensive experience, and through consultation with scientists, experts, and regional DoC staff whenever a shoot is being planned.

How will you approach, film and depart from marine mammals using a vessel?

We intend to approach marine mammals closer than 50m by boat. As our vessel approaches marine mammals at no point will they be cut off. When reaching 300m distance to a marine mammal the vessel will reduce speed to no wake and when departing also travel at no wake speed until 300m from the marine mammal. The exception to this is in the case of dolphins where this may be exceeded in order to outdistance the dolphins, however speed will be increased gradually and will not exceed 10 knots within 300 metres of any dolphin. When the vessel is stationary around a marine mammal it will be placed in neutral or switched off within a minute of the vessel stopping. Trying to chase marine mammals will never be adopted as a filming technique. Topside filming will be carried out from the boat.

How will you undertake underwater filming? Please list all species separately

Method (pole-cam, diver etc.)

We intend to approach marine mammals closer than 100 m underwater for the purpose of filming.

We will use a pole-cam from the boat – which is operated by a person handling the pole and dipping in the water near the marine mammals. All efforts will be made to ensure the pole-cam does NOT come into contact with a marine mammal.

We also intend to sometimes have two people – one with a camera and one as a safety diver drop into the water (as unobtrusively as possible). On snorkel they will film marine mammals near the surface of the water. Attempts will always be made to minimise any disturbance to the marine mammals.

We also intend to sometimes have two people – one with a camera and one as a safety diver drop into the water (as unobtrusively as possible) with scuba tanks. This team will film the marine mammals at depths of up to 30 metres. Attempts will always be made to minimise any disturbance to the marine mammals.

How will you approach and film marine mammals from the shore?

Approach distances for vehicles and people to seals or sea lions

As per the marine mammal protection act. Appropriate legal distance and appropriate distance to minimise disturbance observed at all times.

Filming position relative to seals or sea lions, the shore and the sea

As per the marine mammal protection act. Never between mammal and the sea. Postioning according to legal requirements and to minimise disturbance at all times.

How film crew will be managed in the vicinity of seals or sea lions

Crew will be managed directly by Kina.

Particular behaviour around breeding colonies and nurseries

Minimal disturbance, distance as per law.

What other actions you will take to minimise disturbance including from noise and people behaviour

Noise kept to minimum. Distance kept at all times. Crew managed directly by Kina at all times to act in best practice to minimise disturbance.

How will you approach, film and depart from marine mammals using a drone?

Kina Scollay is a highly experienced drone operator. At all times, the model of drone used will be low noise and non-invasive.

Kina's experience with marine mammals allows him to film them by drone whilst keeping alert for any signs of disturbance. Orientation of approach to be slowly descending in altitude or slowly approaching horizontally.

Approach will be slow and controlled, backing off at the first sign of any disturbance. If a marine mammal shows obvious signs of alarm, agitation or disturbance, Kina will break contact with that particular marine mammal or group of marine mammals for the remainder of that day.

Drone will not be used for longer than 60 mins total in any one day.

The drone will not approach closer than 10m to marine mammals in the water and 50 metres to seals on land.

Filming seals or sea lions on land

Seals or Sea Lions on shore will be approached by slowly descending in altitude or slowly approaching horizontally along or across the shore. Sensible height used as per best practice during transit along the coast or across the sea.

Approaches will be no closer than reasonably needed to film the seal or sea lion. If evidence of disturbance, drone will depart.

Departure from filming animals will be by either gradually increasing in altitude or slowly moving horizontally along the shore.

This long-term marine mammal filming permit application is submitted with the understanding that there needs to exist in New Zealand, an experienced, highly respected marine mammal filming specialist who can manage shoots for local and international projects, ensuring that the best practice will be used to ensure minimal disturbance to marine mammals.

Kina Scollay's marine mammal filming permit is in the interest of the conservation and protection of marine mammals because his highly respected wildlife filmmaking raises awareness of New Zealand marine mammals as taonga that require conservation and protection.

His work influences audiences across New Zealand and internationally. For example, his work on Emmy Award winning Secrets of the Whales showcased New Zealand orca to a global audience, raising huge amounts of awareness of their unique characteristics and the importance of their ongoing conservation.

His marine mammal permit ensures that local and international companies wanting to film marine mammals in NZ have a hugely responsible, best-practice operator to rely on. Kina ensures that any expectations of film projects are kept within the bounds of best practice around marine mammals, that all filming is done within the limits of his permit, and that the interests of the marine mammals take priority in every situation.

D. Background Experience of Applicant

Kina Scollay is the country's most experienced marine mammal underwater cameraman, and has huge levels of experience over 25 years with marine mammals all around New Zealand.

His years of filming under a marine mammal permit that covers so much of New Zealand have occurred without complaint or incident He is the most trusted cameraman around marine mammals in this part of the world.

Kina is respected as having a huge level of integrity with his wildlife work. His ongoing relationships with iwi, stakeholders, communities, scientists and DoC offices are excellent, and characterised by a huge amount of respect on both sides.

Kina has over 25 years of experience working with marine mammals as a cameraman, skipper and commercial diver, and facilitating marine mammal research.

-Provided boat services for DoC and other marine mammal research from 2000 until 2008 on the West Coast (South Island). Including but not limited to both major South Westland Marine Mammal Surveys out of Jackson Bay which included working closely around Dolphins and Seals, primarily Hectors Dolphin and Bottlenose Dolphin.

- Worked closely with with a number of marine mammal researchers on numerous filming and scientific projects
- Held a commercial marine mammal viewing and swimming permit on the West Coast
- He is one of New Zealand's most experienced underwater cameramen, and is known for his careful and sensitive management of filming around marine wildlife, including marine mammals.
- Kina has run and managed many film projects for domestic and international productions where access to marine mammals were required. Every project has been successful, with no concerns reported by any parties. He is relied upon to guide the expectations of international film companies so that they fit with the legal framework of access to marine mammals, and is hired on shoots to make sure that they film within permit conditions and with minimal disturbance to any marine mammal species
- Kina is known as the best in the field for managing permit requirements and film shoot expectations with a high degree of integrity, maintaining the welfare of the marine mammal species as the first priority

Kina has operated as a skipper, underwater cameraman and professional diver in every region across New Zealand for nearly 30 years. He is at home working in challenging and remote locations from the Subantarctic Islands to the Kermadecs. He has an established network of colleagues across the country, and makes a point of consulting with local DoC and marine users in each region to assess conditions and special considerations before every job.

Kina whakapapas to Ngai Te Rangi and Tuhoe and has close connections to Te Atiawa. He forefront's indigenous cultural sensitivity in every encounter with marine mammals. He conducts every shoot - from preparation and planning to in-water encounters in line with these principles.

Having filmed extensively around the country for many years, he has built up relationships with many lwi and Hapu, with whom he has a good record of successful consultation, and has a record of building strong relationships.

He is well aware of the need to carefully consider Maori cultural concerns and sensitivities, and takes the responsibility of communicating Maori stories and knowledge very seriously.

He can provide endorsements as needed in this arena.

F. Public Notification

The Marine Mammals Protection Regulations requires all new permit applications and major amendments to current permits to be advertised, at the Applicant's expense. Submissions will be open for a period of 20 working days. The Applicant will be given the opportunity to respond to any submissions but there is no requirement for a hearing.

If an application is to renew an existing permit on terms and conditions that, in the opinion of the Department, are substantially the same; to transfer an existing permit to a new holder; or to make a minor amendment to a current permit then notification is not required.

G. Fees

Processing Fees:

Section 60B of the Conservation Act contains the statutory provisions regarding processing fees.

The Department recovers all direct and indirect costs to process a marine mammal permit application from Applicants regardless of whether the application is approved or declined.

The estimated cost of processing a **standard renewal** of an existing marine mammal permit is **\$1540 + GST**.

The estimated cost of processing a **standard new application or major amendment** will be **\$1540 + GST** plus the costs of advertising.

The estimated cost of processing a **new application or major amendment where there are submissions** received from the advertising will be **\$2000 + GST** plus advertising costs.

Where the application is more complex than a standard process, the Applicant will be sent an estimate of costs in this situation. Applicants are also entitled to request an estimate of costs at any point but the Department may impose a charge for preparing such an estimate. Estimates are not binding.

The Department will ordinarily invoice the Applicant for processing fees after a decision has been made on the application but in some cases interim invoices will be issued. If at any stage an application is withdrawn the Department shall invoice the Applicant for the costs incurred by the Department up to that point. Applicants are required to pay the processing fees within 28 days of receiving an invoice. The Director-General is entitled to recover any unpaid fees as a debt.

- (b) That the commercial operation should not be contrary to the purposes and provisions of the general policy statements approved under section 3B of the Act, conservation management strategies approved under section 3C of the Act, or conservation management plans approved under section 3D of the Act:
- (c) That the commercial operation should not have any significant adverse effect on the behavioural patterns of the marine mammals to which the application refers, having regard to, among other things, the number and effect of existing operations:
- (d) That it should be in the interests of the conservation, management, or protection of the marine mammals that a permit be issued:
- (e) That the proposed operator, and such of the operator's staff who may come into contact with marine mammals, should have sufficient experience with marine mammals:
- (f) That the proposed operator, and such of the operator's staff who may come into contact with marine mammals, should have sufficient knowledge of the local area and of sea and weather conditions:
- (g) That the proposed operator, and such of the operator's staff who may come into contact with marine mammals, should not have convictions for offences involving the mistreatment of animals:
- (h) That the commercial operation should have sufficient educational value to participants or to the public.
