MEMORANDUM-DIRECTIONS OF CHIEF JUDGE W W ISAAC REGARDING PLANNING FOR HEARING ONE OF THE STAGE ONE INQUIRY

26 April 2023

Hearing planning

Background

- 1. On 17 February 2023, I issued a memorandum-directions confirming that the Military Veterans Kaupapa Inquiry (Wai 2500) will proceed in two stages (Wai 2500, #2.5.83 at [28]):
 - (a) Stage one will focus on claims concerning Parts Three, Four and Five of the Tribunal Statement of Issues (TSOI).
 - (b) Stage two will focus on claims concerning historical conflicts reflected in Parts One and Two of the TSOI.
- 2. I also confirmed that hearing one of stage one will be held in the week of 12 June 2023, in Rotorua. The venue was to be confirmed in future memorandum-directions (Wai 2500, #2.5.83 at [34]).
- 3. To assist with stage one hearing planning, I directed co-ordinating counsel to confer with inquiry parties and file a memorandum advising (Wai 2500, #2.5.83 at [32]):
 - (a) the conflict(s) or operation(s) in which the claimants intend to bring evidence;
 - (b) the number and location of any veteran witnesses counsel intend to call; and
 - (c) the specific witnesses counsel intend to recall from our earlier oral evidence hearings phase.
- 4. I sought responses from parties on several matters, including proposals for further research, claims concerning nineteenth-century domestic campaigns, and the Crown's updated timeframe for filing its final statement of response (and any early concessions or acknowledgements). (Wai 2500, #2.5.83).
- 5. I confirm that the Tribunal has received the responses outlined at [3] [4] above, as directed.

Hearing one

- 6. I am mindful that there is not an abundance of time until the first hearing scheduled in June 2023, and that there is a need to provide certainty to parties in preparation for this hearing.
- 7. Therefore, I now direct co-ordinating counsel to file a memorandum by **12pm**, **Wednesday 10 May 2023** addressing:
 - (a) the claims to be heard in hearing one;
 - (b) the number of days required for hearing; and
 - (c) a suggested hearing venue in Rotorua.
- 8. In my 17 February 2023 memorandum-directions, I confirmed the hearing of two Tribunalcommissioned reports: Wai 2500 #A251, chapters 5-9; and Wai 2500 #A250 (Wai 2500, #2.5.83 at [35]). This evidence will require two days to present.

9. The Tribunal's preferred approach to organising stage one hearings more generally will be confirmed in due course.

Draft inquiry timetable

- 10. **Attached** as **Appendix A** is a draft inquiry timetable, noting key filing dates and milestones ahead of hearing one.
- 11. Counsel are now invited to provide any feedback on this draft by **12pm**, **Wednesday 10 May 2023**.

Wider inquiry planning matters

12. Finally, I confirm that the Tribunal will address wider inquiry planning matters in a future memorandum-directions.

The Registrar is to send this direction to all those on the notification list for Wai 2500, the Military Veterans Kaupapa inquiry.
