## 4.2 Matter arising GM Report

#### Fisheries & MACA Hui

Due to the fact the Kahukuraariki Trust was not enshrined within the Māori Fisheries Act 1993, and the Māori Commercial Aquaculture Claims Settlement Act, 1993, as either a representative Iwi Organisation (RIO), or a Mandated Iwi Organisation (MIO), the only way it would be able to access its share of fisheries and aquaculture Assets. TRoW has already done this. It would take a change of legislation and no-one is prepared to do that. Therefore, the only course of action available to the Trust is to discuss the matter with the TRoW Board.

The MACA hui is happening on the 27th May, GM to attend

#### TRoW - KTB kanohi ki te kanohi

TRoW have agreed to meet with our Trustees, the first hui should be a whanaungatanga hui with each other and discuss governance mahi. We could present our Strat Plan and TRoW have agreed to presenting their Strat Plan, they are currently updating their Strat Priorities, we need to korero to our Marae representatives on the TRoW board about our tono to have a hui before the hui happens.

#### Taupo abstain from the decision to attend.

The long term plan could be to get regular/periodic reports from TRoW regarding the social and health services they are delivering in our rohe, to provide a clearer assessment if thosem services are fit for purpose or whether the Trust Board needs to do look for alternative solutions for Hauora and Social services delivery.

#### Te Taitokerau Māori Advisory Council - TTMAC, NRC

TKoT are part of this roopu, The GM proposed the Taupo Marae Trusteee, Waitangi Woods might like to participate in the forum on behalf of the Trust, given her strong interest and advocacy in this natural resource management. Waitangi to think about it. Pita Tipene is the Co-Chair of this roopu. Tui Shortland is the chairperson of NRC.

#### NROP and Aquaculture

This project is going well, the working group have been in conversations with MBIE with the next steps and also with MPI to source external funding to trial farming and proof of concept, as well as set up a spat production hatchery in Bream Bay. NIWA have also brought in a geneticist which will help the project with gene selection. Waitangi advised she still needs to meet with the GM to discuss the project and how Ngati Rua fits in.

The Trust has been offered the opportunity to put in 2 lines in marine space next to an established pacific oyster farmer, utilizing the aquaculture mold system (AMS), in the Kerikeri Inlet. He and his staff would look after our 2 lines of rock oyster spat growing out in the new system. He has secured the space next to his farm so he can expand. This is the space we will be farming for now.

We are currently looking for kai mahi to learn and work on the farm. We have advertised on our website. It would be very helpful if the Trustees could also spread the news. Waitangi has some people who may be interested. She will forward names of those who may want to learn. It was stressed the work is for those with an interest – not just youths but older lwi members who may be looking to retrain. Norm to take it up with the Waitaruke Marae committee.

The GM to have a korero with Ngati Rehia to let them know we are farming in their rohe.

#### Te Arawhiti

There was some korero about the upcoming Te Arawhiti hui, Geraldine to have a conversation with David Manuel and other former KTB Trustees regarding the gaps in the historical history with the iwi settlement.

Her current understanding (from Dave Manuel), is that the Crown gave a verbal commitment to unencumber the occupation on Stony Creek prior to settlement, but we don't have written confirmation. The GM has instructed our lawyers (Kahui Legal), to request correspondence during that period of time from Te Arawhiti under the OIA.

Waiting to hear back from Kahui Legal as to the meeting being set up with Te Arawhiti. We are insisting that the CE be present.
