Workforce commissioning update

Alana Ewe-Snow, our Director Workforce Commissioning,

- It's been a busy time in the workforce commissioning space, with several public announcements about funding decisions made in the last fortnight.
- Investment of
 - \$1M in [Ngā Manukura](#), kaupapa Māori clinical leadership programme to develop leaders within nursing and midwifery.
 - \$1.7M in Te Pūhoro develop a bespoke career health pathway that support rangatahi Māori into future study and careers in [STEMM](#)
 - Te Ao Marama Aotearoa to run a national kōrero with and led by tangata whaikaha Māori

Cervical screening update

- In partnership with Te Whatu Ora, we launched the new HPV self-test and associated campaign earlier this week. This space is managed by our Public and Population Health team.
- Cervical screening campaign was launched at Kōkiri Marae in Wellington; full release of campaign covered, print, digital, television and radio
- The campaign is hoped to boost numbers of Māori wāhine who can now self-screen for HPV

- Manatū Hauora released a [Cabinet Paper](#) outlining the need for a comprehensive work programme to address issues in primary and community healthcare.
- Te Aka Whai Ora is working with Manatū Hauora and Te Whatu Ora on this important mahi to ensure that this critical part of the health system is affordable, sustainable, and equitable.
- Work is just getting underway and builds on the [Pae Ora Act](#) and the [Pae Ora Strategies](#)
- Manatu Hauora is the lead policy agency with a focus on systems settings.
- Te Aka Whai Ora is contributing to this mahi and also working on our strategies that will feed into this work which is expected to run for 18-months (to end of Dec 2024)

Iwi Māori partnership boards update

Presented by Teei Kaiaruna (GM Iwi Māori Relationships, Mātauranga Māori)

- Regional hui held for Te Manawa Taki rohe.
- The regional integration team present back the priorities they have been collecting from IMPBs to contribute to the Regional Health and Wellbeing Plan for the region.
- Regional Integration Team is co-chaired by Nicola Ehau at Te Whatu Ora and Te Aka Whai Ora Stewart Ngatai; supported by Teei Kaiaruna (GM Iwi Māori Relationships) and Hiria Paki, (Lead Regional iwi Māori relationships)
- Outcomes are an example of how strengthening our approach in the regions.
- Iwi Relationship Leads working with IMPBs to determine their locality boundaries and operationalising what legislative requirements look like in practice.
- Setting up working groups to ensure flow of information between the partners (Te Aka Whai Ora, Te Whatu Ora, IMPBs and Localities) is seamless.

- It is clear everyone wants to engage with IMPBs. The team are working to ensure that those requests do not overwhelm the IMPBs, and engagement is managed in a manner that benefits everyone and
- The priorities for working groups are – monitoring, data and digital, kaupapa Māori investment. Expressions of Interest if you wish to be part of these groups will be going out soon.
- Roadshow in planning and we will notify everyone once dates and plans are confirmed.

Data, Digital and Knowledge Systems | GM Kadin Latham

- As many of us in the health sector know, it is critical that we invest in data and digital solutions to help us drive the change that is needed to improve the health and wellbeing outcomes of whānau Māori.
- A focus has been defining what does a data, digital and knowledge systems mean for Te Aka Whai Ora and how does this work enable the intent of the reforms.
- Result is four strategic priorities for the team.
 1. Equipping IMPBs with the tools, data, and insights they need for local priorities.
 2. Partnering with Manatu Hauora, Te Whatu Ora and hauora partners to deliver data and digital solutions.
 3. Providing internal teams in Te Aka Wahi Ora with data and insights
 4. Driving and influencing the health sector to deliver matauranga Māori and Te Tiriti in how they deliver data and systems knowledge.
- Been working with agency partners and first deliverable will be a suite of IMPB statistical profiles.
- Developing and maintaining a **Māori Sovereignty Framework**
- Developing and maintaining Oranga Whānau Outcomes Framework
- Developing Māori Research Agenda of priorities
- [National Data Platform](#) – Te Whatu Ora announce the development of this platform. It was recognised that data needed to be streamlined this platform will do that and store all the health data – **Note:** Data Sovereignty Framework will ensure that the platform reflects and protects Māori data.

Service Commissioning (Funding) update Ben Hingston

- Te Aka Whai Ora Commissioning for Hauora Māori Outcomes is a move from traditional procurement and commissioning models to a commissioning for outcomes model and is a key transformational lever for us. It is not a one and done process
- In terms of the renewals for contracts that expired you're still receiving additional uplifts for those – 96% have been processed, four-percent outstanding but expecting to complete those by our next hui.

Regional – Te Manawa Taki Regional Director, Stewart Ngatai

- Stewart Ngatai, Te Manawa Taki hosted the regional hui as referenced by Teei Kaiaruna
- Discussion at Te Manawa Taki hui was around how do you scaffold from regional priorities from hauora Māori partners to IMPBs which are solicited from whānau voice as well
- Then how does that fit into the regional health services planning – regionally work is being done to align the conversations and the needs of the region?

- Teams are working on two priorities that are before them
 1. Hauora Provider contracts
 2. Five-year hauora Māori plans.
- Regional team are working with national teams to align the priorities.

Pātai from the hui

How will we know if we have been “accepted” into the social worker pay parity claim. There has been no confirmation although we noted this in in the survey earlier in the year.

We are still waiting on the final list of confirmed hauora Māori partners who have been identified to receive this funding from Te Whatu Ora and have been told this is to come in today/tomorrow. We will then send this out to you as soon as we receive the information. If you expect to hear from us and have not received anything, please reach out to your

relationship lead to escalate this up to the team and we will ask Te Whatu Ora for more information.

What's the timeframe in setting up platform so we are enabled to communicate with one another as IMPBs?

Whiria is the intranet platform and is now available for all IMPB members to onboard. There is a [short registration form to complete for IMPB members](#) and each IMPB will need to have in place a delegated authoriser who can provide confirmation that their respective IMPB approves the onboarding of members from their rohe.

Once the registration form has been authorised by the IMPB, a username and temporary password will be sent out with 3 working days. Users can then interact with Whiria and participate in discussions with IMPB members across the motu.
